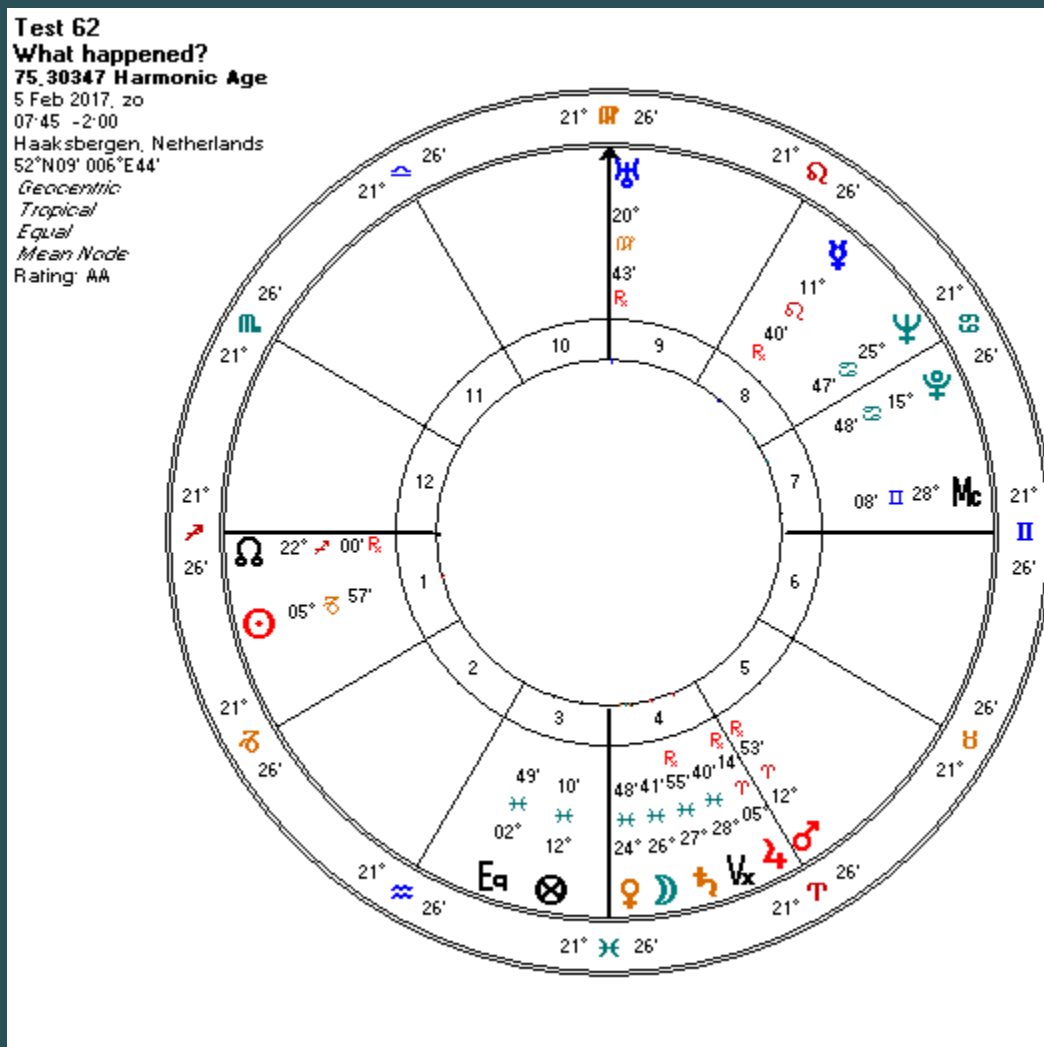


# ZODIJACK©

Astrology

This answer is option 1: her mother in law passed away (at the age of 101 years).



The answer in the AH Chart is shown as follows:

Mother in law = 10<sup>th</sup> from the 7<sup>th</sup> = natal 4<sup>th</sup>

- Neptune is in the 8<sup>th</sup> AH House of death, square Saturn in the 4<sup>th</sup> AH House conjunct the Moon ruler of the 8<sup>th</sup> House in the 4<sup>th</sup> House of her mother in law (or death within the family)
- Venus, Ruler of the 8<sup>th</sup> of the mother in Law, square Neptune
- Venus, Ruler of the 8<sup>th</sup> House of death of the mother in law is in the 4<sup>th</sup>

8 Astrologers participated in the Test. Finding the answer was difficult for the most. 3 Astrologers found the correct answer. Their answer follow below in order of receipt:

### **Matthieu Kaiser (Germany)**

uses symbolic Directions, Quotidian

In the symbolic directions, the North Node is conjunct Venus (ruler of the 8<sup>th</sup> House) on 3 February.

On the native's birthday, the profected Ascendant is in Capricorn, in the 3<sup>rd</sup> House, conjunct to the Lot of Death. Saturn is the lord of the year. In the natal chart, it is almuten of the 4<sup>th</sup> House (i.e. the 10<sup>th</sup> of the 7<sup>th</sup>, standing for the husband's mother), in the 8<sup>th</sup>, with which it relates to death. On the birthday, Saturn is transiting Sagittarius, the 12<sup>th</sup> sign from the profected Ascendant, hence the risk of fatal separations from the native during the year. With the whole sign system, Mars, the ruler of the 4<sup>th</sup> sign counted from the profected ascendant, is conjunct Pluto in the 1st house. Besides, by profection, Saturn, ruler of the natal 4th house, is in detriment in Leo, occupied by natal Pluto.

On the event's day, the profected Ascendant is transited by Mercury, ruler of the natal 11<sup>th</sup> House (which is the 8<sup>th</sup> of the 4<sup>th</sup>).

In the quotidian chart, the Descendant is conjunct natal Pluto. Mercury, which rules the 4<sup>th</sup> House, is in the 12<sup>th</sup> House, square Jupiter, ruler of the 11<sup>th</sup> (8<sup>th</sup> of the 4<sup>th</sup>), and Uranus. Mercury is also in the 12<sup>th</sup> sign from this occupied by the Sun, ruler of the 7<sup>th</sup> House (the husband), which is in detriment. Besides, the Sun is in trine with Jupiter, ruler of the 10<sup>th</sup> House (i.e. the 4<sup>th</sup> for the husband: his ancestral roots), which occupies the 8<sup>th</sup> (i.e. the husband's 2<sup>nd</sup> House: his finances). Also Mars, which rules the 2<sup>nd</sup> House (his 8<sup>th</sup> House) trines the MC (his IC). All this favours an increase in his personal finances coming from his family's wealth by inheritance.

The day after the event, Jupiter stationed at 23° Libra, in conjunction with the Sun, almuten of the 7th house, squaring the IC and the Lot of Death. Saturn's latest station was at 9° Sagittarius, conjunct Venus, ruler of the 8<sup>th</sup> House.

The latest solar eclipse occurred at 9° Virgo, in square with Venus, ruler of the 8<sup>th</sup> House. The latest lunar eclipse occurred at 24° Pisces, opposite the Moon, almuten of the 8<sup>th</sup>

### **Jacqueline (France)**

uses the AH Technique

- In this chart Uranus, in conjunction with the Cusp of the 10<sup>th</sup> House, attracts the attention, opposite to the cluster of Planets in the 4<sup>th</sup> House, the 10<sup>th</sup> of the 7<sup>th</sup> House, which is afflicted by this opposition.
- Venus Almuten of the 4<sup>th</sup> House Pisces, is in conjunct the Moon, the Ruler of the 8<sup>th</sup> House, and Saturn the natural significator of death.
- The Vertex, the blow of fate, and Mars, the Ruler of the 12<sup>th</sup> House square Pluto, death and destruction and violence, notably on the Cusp of the 8<sup>th</sup> House.
- Jupiter, the Ruler of the 4<sup>th</sup> House.
- Mercury Significator of the husband of this woman, in the 8<sup>th</sup> House.
- Neptune dispositor of the 4<sup>th</sup> House, is in the 8<sup>th</sup> House.
- Venus also the Dispositor of the 8<sup>th</sup> House counted from the 4<sup>th</sup>

### **S L Narasimhan (India)**

Uses- Khullar Cuspal interlinks using SSL

Dasa running on date was Mercury- Mercury -Venus-Mars- Mercury.

All these planets are not only ruling planets of 1-2-7-8 and badka of her mother-in-law but significators of these Houses. Thus dasa paved way for the event

Transit- Moon transits in Venus sign (Antara lord) and Sun star. SUN is the star lord of 8th SSL of mother-in-law. Sun transits in Moon star which is significator of 1-2-7-8 and badka of mother-in-law.

Virtual Transit - Progressed Ascendant SSL on the day of event is Mercury whose role is discussed above. Moon's Progressed position also operates death giving places .
