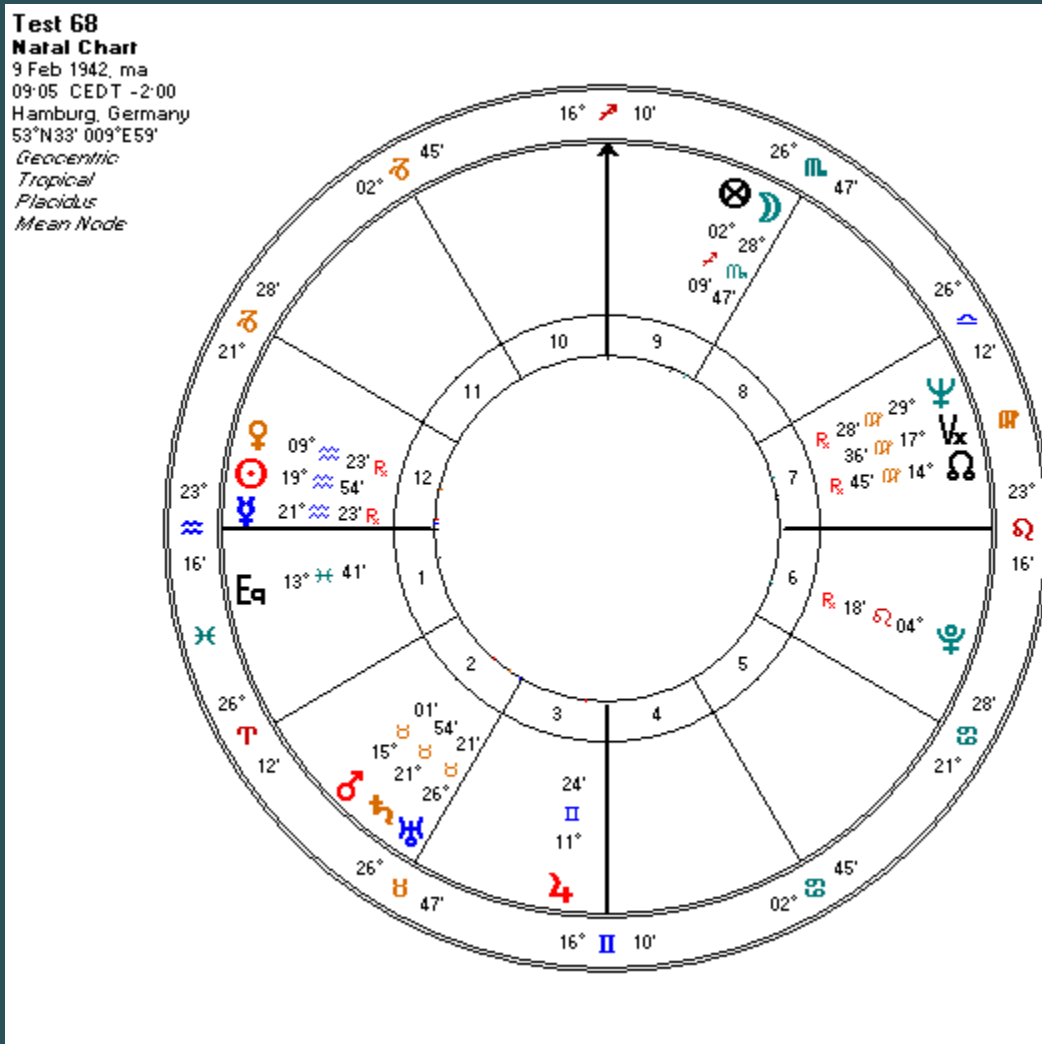


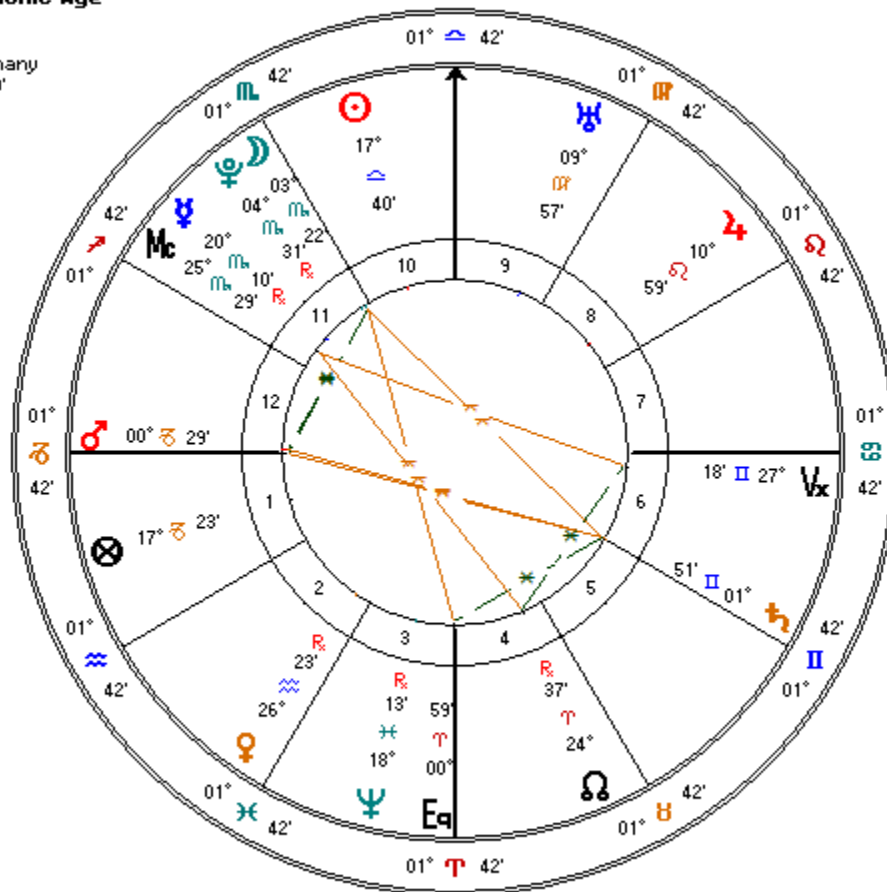

At first you look at it there is a possibility to win a lottery in the Birth Chart. Pennies from Heaven = 11th House with dispositor Saturn. Saturn is in his 2nd natal House of money conjunct Mars, Ruler of the 2nd House. So yes.... there is a potential of winning a lottery!
 Note that Mars and Saturn play a significant role.

In the AH Chart Mars, classic Ruler of the AH 11th House is right on the Ascendant. As you all know, Planets on Cusps, especially of the Corner Houses, attract our attention.

There are two Yod's:
 Moon is conjunct Pluto in the 11th House, forming a Yod figure with Mars and Saturn, Classic Ruler of the AH 2nd House.

And the same Moon/Pluto conjunction forming a Yod with Saturn and the Equatorial Ascendant.

Below follow their answers in order of receipt.

Pierre le Gal (France)
uses Vedic astrology – Ayanamsa Raman, Placidus Houses

Mercury is in a nakshatra of Mars, Dhanishta. Mercury signifies numbers and games. In this Chart, it rules also the 8th House of death and unknown and the 5th House of amusement and fun. Mercury is conjunct to the Sun, which indicates success. Dhanishta means “Abundance” (Light on Life, Defouw and Svoboda, page 101). And also with the Lagna or the Moon there : “a liberal, rich person, brave and fond of music.” (idem, page 241). Dhanishta is strong by its position at the Ascendant, by the position of its Ruler Mars, Ruler of the sub-period also, placed in its mulatrikona Aries in the second House of money. Mars is aspected by Rahu, which can increase the gains.

Erika Eilert-Hein (Germany)
uses the AH Technique

- The focus is on the 11th House, the 2nd from 10th (state lottery)
- Mars, ruler 11th House conjunct the Asc.
- Venus, Ruler 5th House (gambling) and the planet for money square Floating Mc
- Mars square Eq. Asc.

- Sun, Ruler of the 8th , money from other people in 10

The event was clearly to recognize in the Lunar Phase from 6.2.1964:

- Venus, ruler 2nd House in trine to ruler 5th House, the Moon
- Saturn, ruler 11th House square the Ruler of the 5th
- Natal: Ruler AC and 11th House is Saturn in 2, in the sign of money (Taurus), conjunct Uranus, co-ruler Asc, Mars in 2, rules the 2nd House

Mattieu Kaiser (France)

On October 21, 1963, Saturn stationed direct at 16° Aquarius, in conjunction with the Sun (almuten of the 2nd House) and in close square with Mars (ruler of the 2nd). This station was activated on February 3 by a conjunction of Mars in transit.

On December 5, 1963, Jupiter stationed direct at 9° Aries, in partile sextile with Venus (almuten of the 8th house, which signifies the others' money).

On January 14, 1964, a solar eclipse occurred at 23° Capricorn, in trine with Saturn (almuten of the 8th). This eclipse was activated on February 6 by Mercury transiting in conjunction.

In the Lunar Return adjusted for the equinox precession, Jupiter was on the MC, which in itself is a strong signifier of substantial money inflows. Jupiter was in sextile with the Sun conjunct Mars, which were respectively the almuten and the ruler of the natal 2^d house. The Ascendant was conjunct with natal Pluto, showing a month of major psychic upheaval. The Descendant was conjunct with natal Venus, hence a pleasant period of time, so the upheaval should have been for positive reasons.

In the quotidian chart, Saturn, almuten of the 1st and the 8th , was in its own sign in the 1st house, and forming a cluster around the Ascendant with the Sun and Mars, respectively almuten and ruler of the 2nd House as in the Birth Chart. Venus, the other almuten of the 8th , was also dignified in the 1st House.

Aurore Paquet France
uses the AH Technique

Mars Ruler of the natal 2nd House is conjunct the AH Asce.

Pars of Fortune is in the 1st AH House exact square the Sun Ruler of the 8th House of other peoples money.

Inès Pamestri (Switzerland)
uses the sidereal Zodiac

I notice that on the day of the event (February 9th 1964) the lord of the 1st House transited the ascending degree, bringing more happiness and prosperity to the native. In the natal Chart, Jupiter, the significator for prosperity, is placed in the 4th House, the House of the assets, from which it closely aspects Venus, the lord of the 9th House of luck, fortune and unexpected gains. And on the day of the event, both Jupiter and Venus transited the 2nd House, the House of wealth, in Pisces where these two Planets gain strength.

It thus sounds very probable to me that the native won a large amount of money in the lottery on that day.
